Academy Nomination Application Checklist

A complete application packet consists of all items requested below. Only complete packets will be reviewed and considered for nominations.

- ☐ Application is completed and signed
- ☐ Include an activities resume which lists awards, special recognitions or activities you would like to highlight. This may include, but is not limited to athletic activities, extra-curricular activities, leadership roles, awards and honors, community involvement and employment experience
- ☐ Two letters of recommendation supporting your nomination. Letters may not come from immediate or extended members of your family. Suggested individuals include: teachers, coaches, school principals and staff, employers, clergy, counselors, community leaders, etc.
- ☐ Essay of 500 words or less entitled, "Why I wish to attend the (name of academy) Academy." Evaluations will be based upon both writing skill and content of essay
- ☐ Sealed/official copy of high school transcript
- ☐ Sealed/official SAT and/or ACT scores. A certified copy is required for your application to be complete. You can submit directly to our office or you may request direct delivery of your scores. To do so, include the following codes on your test form: SAT (0192) and ACT (7290)
- ☐ Unofficial SAT/ACT scores included in your application package. Please submit unofficial scores as they become available. It is in your interest to take the SAT and/or ACT tests as often as possible
- ☐ A recent small photograph of yourself (approximately 3" x 4")
